Wall Trucking is exempted from the payment of Customs Duty and Consumption Tax on the importation of four (4) dump trucks if the dump trucks are imported solely for use in the mining industry.

Wall Trucking is exempted from the payment of the processing fee on the importation of the items referred to in paragraph 2.

Expiration
This Order expires on 31 December 2019.

Repeal
The Customs Duties and Consumption Tax (Wall Trucking) (Exemption) Order 2019 (S.R.O. 1 of 2019) is repealed.

THE CUSTOMS DUTIES AND CONSUMPTION TAX (WALL TRUCKING) (EXEMPTION) (NO. 2) ORDER 2019 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTIONS 8 AND 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17).

1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (Wall Trucking) (Exemption) (No. 2) Order, 2019.

2. Exemption

Wall Trucking is exempted from the payment of Customs Duty and Consumption Tax on the importation of four (4) dump trucks if the dump trucks are imported solely for use in the mining industry.

3. Processing fee

Wall Trucking is exempted from the payment of the processing fee on the importation of the items referred to in paragraph 2.

4. Expiration

This Order expires on 31 December 2019.

5. Repeal

The Customs Duties and Consumption Tax (Wall Trucking) (Exemption) Order, 2019 (S.R.O. 1 of 2019) is repealed.
