THE CUSTOMS DUTIES AND CONSUMPTION TAX (DEEPAK ENTERPRISES LIMITED) (EXEMPTION) ORDER 2019 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTIONS 8 AND 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17).

1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (Deepak Enterprises Limited) (Exemption) Order, 2019.

2. Exemption

Deepak Enterprises Limited is exempted from the payment of –

- (a) Customs Duty and Consumption Tax on the importation of the items set out in the Schedule; and
- (b) Customs Duty on the importation of one Rav 4 Jeep.

3. Processing fee

Deepak Enterprises Limited is exempted from the payment of the processing fee on the importation of the items set out in the Schedule.

4. Expiration

This Order expires on 31 March 2020.
