TAX COMPLIANCE CERTIFICATE ACT

(Acts 8 of 2012 and 2 of 2017)

AN ACT TO MAKE PROVISION FOR THE ISSUANCE OF TAX COMPLIANCE CERTIFICATES.

Commencement

[8 May 2017]

Short title

1. This Act may be cited as the Tax Compliance Certificate Act.

Interpretation

2. In this Act—

“**Comptroller**” means the Comptroller of Inland Revenue;

“**Income and Corporation Tax Act**” means the Income and Corporation Tax Act (Cap. 17.01);

“**Minister**” means the Minister responsible for Finance; and

“**Property Tax Act**” means the Property Tax Act (Cap. 17.16);

“**Social Security Act**” means the Social Security Act (Cap. 18.09);

“**Tax Compliance Certificate**” means a certificate issued under section 5.

Requirement for a Tax Compliance Certificate

3. A person who submits—

- (a) a tender for a government contract; or
- (b) an application for—
 - (i) a concession;
 - (ii) permanent residence or economic residence; or
 - (iii) the extension of a work permit,

must include with his or its submission or application a valid Tax Compliance Certificate. *(Amended by Act 2 of 2017)*

Application

4. A person may apply to the Comptroller for a Tax Compliance Certificate using Form 1 of the Schedule and the application must be accompanied by—

- (a) in the case where the applicant operates a business, the certificate of incorporation or the certificate of registration of the business name, if the business is not carried on in the name of an individual;
- (b) a fee of \$20; and
- (c) any other information required.

Issuance of Tax Compliance Certificate

5. (1) The Comptroller must issue to a person a Tax Compliance Certificate set out in Form 2 of the Schedule if the Comptroller is satisfied that the person has—

- (a) paid all—
 - (i) taxes payable under the Income and Corporation Tax Act and the Property Tax Act; and
 - (ii) social security contributions due under the Social Security Act; or
- (b) made arrangements satisfactory to the Comptroller to pay outstanding—

- (i) taxes payable under the Income and Corporation Tax Act and the Property Tax Act; and
- (ii) social security contributions due under the Social Security Act.

(2) A Tax Compliance Certificate issued—

- (a) under subsection (1)(a) is valid for one year; and
- (b) under subsection (1)(b) is valid for three months, from the date on which it is issued.

(3) A Tax Compliance Certificate issued under subsection (1) is proof of tax compliance for the purposes of the Income and Corporation Tax Act, the Property Tax Act and the Social Security Act.

Refusal

6. A person may be refused a Tax Compliance Certificate if—

- (a) an income tax return or income tax under the Income and Corporation Tax Act;
- (b) property tax under the Property Tax Act; or
- (c) any contribution under the Social Security Act,

is outstanding.

Revocation

7. (1) The Comptroller may revoke a Tax Compliance Certificate issued under section 5 if the applicant at the time of making the application, knowingly furnished particulars that are found to be either materially incomplete or false or likely or calculated to deceive.

(2) A Tax Compliance Certificate may be revoked without prejudice to existing contracts.

Appeal

8. A person who is refused a Tax Compliance Certificate under section 6 or whose Tax Compliance Certificate is revoked under section 7 may appeal to the Minister against the decision of the Comptroller.

Regulations

9. The Governor acting on the advice of Cabinet may make regulations for carrying out the purposes of the Act.


