THE PUBLIC HEALTH (COVID-19 SUPPRESSION) (NO. 2) (AMENDMENT)
ORDER 2022 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET
UNDER SECTION 10 OF THE PUBLIC HEALTH ACT (CAP. 14.01).

1. Citation and commencement

This Order may be cited as the Public Health (Covid-19 Suppression) (No. 2) (Amendment) Order, 2022 and comes into force 14 February, 2022 at 5 a.m.

2. Interpretation

In this Order “principal Order” means the Public Health (COVID-19 Suppression) (No.2) Order, 2022 (SRO No. 5 of 2022).

3. Paragraph 2 amended

Paragraph 2 of the principal Order is amended by deleting the definition of—

(a) “**large gathering**” and substituting the following—

“**large gathering**” means a gathering of more than seventy-five persons;”

(b) “**non-resident technician**” and substituting the following—

“**non-resident technician**” means—

(a) a person who travels to Montserrat for the purpose of assisting with certification and maintenance of equipment and includes;

(b) a vaccinated medical specialist engaged by a public or private entity who travels to Montserrat for no more than ten days; and”

(c) “**professional person**” and substituting the following—

“**professional person**” means a person whose job requires—

- (a) one year training or work experience and whose job is not of a temporary or seasonal nature; or
- (b) a diploma or certification and whose job is not of a temporary or seasonal nature.”

4. Paragraph 14 amended

Paragraph 14 (1)(a) is deleted and substituted with the following—

“(1) A fully vaccinated person who goes directly to his home, place of occupancy, designated quarantine facility or place of isolation shall remain at his home, place of occupancy, designated quarantine facility or place of isolation until the sooner of the following—


- (a) five days has elapsed, provided a PCR COVID-19 test or a RNA COVID-19 test taken between three and five days after he enters Montserrat shows that he is not infected with COVID-19; or”

5. Paragraph 39 amended


Paragraph 39 of the principal Order is deleted and the following is substituted—
