THE CUSTOMS DUTIES AND CONSUMPTION TAX (VITAL AUTO PARTS LTD) ORDER 2022 MADE BY THE GOVERNOR ACTING ON THE ADVICE OF CABINET UNDER SECTION 19(2) OF THE CUSTOMS DUTIES AND CONSUMPTION TAX ACT (CAP. 17.05).

1. Citation

This Order may be cited as the Customs Duties and Consumption Tax (Vital Auto Parts Ltd) (Exemption) Order, 2022.

2. Exemption

Vital Auto Parts Ltd is exempted from the payment of Customs Duty and Consumption Tax on the importation of the items described in the Schedule.


